


GHHI Healthy Homes Asthma Intervention Strategy (based upon Comprehensive Environmental Assessment) -

- Integrated Pest Management
- Mattress and pillow cover installation
- Air filtration unit in child's bedroom
- HEPA-Vacuum and Indoor Allergen Kit
- Other Asthma Trigger Reduction Measures
- Venting of kitchen, bathroom and dryer
- Removal or steam cleaning of carpets
- Mold remediation
- Air conditioner/dehumidifier installation
- Furnace filter replacement
- Multiple Resident Education home visits

GHHI Asthma Post Intervention Evaluation Results

- 66% reduction in asthma related client hospitalizations post intervention
- 50% increase in children never having to visit the doctor's office due to asthma episodes
- 88% increase in participants reporting that their child didn't have to work harder to breathe
- 62% increase in asthma-related perfect school attendance (0 school absences due to asthma)
- 88% increase in participants never having to miss a day of work due to child's asthma episodes

GHHI National Impact

- 509,726 Green & Healthy Homes units completed using integrated health, energy and housing intervention model
- \$404 per year average energy consumption cost reduction
- Government cost savings (20-25%) through more efficient processes
- Over 1,800 persons cross trained in green and healthy assessments and interventions

Philanthropy and Private Investment

- Partnerships with Council on Foundations, CF Leads, The Funders' Network for Smart Growth and Livable Communities, Living Cities, and other philanthropic groups

- Partnering with Urban Institute for cost benefit analyses
- Conducting HUD Healthy Homes Technical Study with UMBC Hilltop Institute to measure
 Medicaid medical cost savings and cost benefits of GHHI interventions

Upcoming Activity and Development

- Financing tools and new social enterprise models
- Software programs for assessment, client triage, and housing intervention resource braiding
- Developing payment models for asthma interventions based on present value health savings
